Range Safety Officer Class

The NRA Range Safety Officer program was developed in response to the demand for a nationally recognized range safety officer certification. NRA Range Safety Officers are people who possess the knowledge, skills, and attitude essential to organizing, conducting, and supervising safe shooting activities and range operations. An NRA certified RSO is required for many BSA shooting sports activities.

This course is only open to members of the Shortsville Gun Club OR members of the Boy Scouts of America.

What you will learn:

- Introduction to the NRA Basic Range Safety Officer Development Course
- The Role of the NRA Range Safety Officer and Range Standard Operating Procedures
- Range Inspection and Range Rules
- Range Safety Briefing
- Emergency Procedures
- Firearm Stoppages and Malfunctions

In order to complete certification, applicants must participate in all six lessons and complete and earn at least a 90% grade on the range safety officer exam and register on the NRA instructor site to submit the appropriate fees to the National Rifle Association.
