## VEHICLE DRIVING/RIDING REGULATIONS

These regulations apply to all persons having a written Employment Contract as camp staff members of the Glacier's Edge Council, Boy Scouts of America. These regulations apply to all motorized vehicles. Youth protection guidelines will be in effect at all times.

1. Staff personnel under 18 years of age may be a passenger in a vehicle driven by non family members ONLY when approved by parents and camp director.

2. Drivers who are 16 and 17 years old may not carry passengers in their personally driven vehicles to or from camp at any time unless they are family members.

*Initials of Staff Member and Parent/Guardian if under 18:* \_\_\_\_\_

3. Drivers must have passenger's parental and camp director approval to carry passengers in a personally-owned vehicle. The camp director will give approval to carry passengers only for official camp business or in case of an emergency.

4. No camp vehicle will be driven on camp property or beyond the limits of the camp unless on official camp business and approved by the camp director or camp ranger.

5. The maximum speed limit for all vehicles on the camp property is 10 mph except where otherwise posted.
